APPLICATION IS HEREBY MADE FOR BOURSE SPACE FOR THE PERIOD OF THE ABOVE-MENTIONED BOURSES.

The coin and stamp bourse is scheduled for the third Sunday of each month, begins at 10:00 am, and continues to approximately 3:00 pm. Dealers enter and leave through the rear doors only. Doors open at 8:30 am for dealer set up only. Tables are not transferable. Failure to attend will result in "forfeiture" of said fee. Since the public judges the quality of a show by the number of dealers present, contracted dealers must give notification by calling one of the Bourse Chairpersons five (5) days before the show if they cannot make the upcoming show. The club has a waiting list of dealers who want to set up. This practice will strengthen the show, and it will help your business too. Armed guard service will be provided for the bourse area. The premises must be vacated by 4:00 pm each Sunday.

Neither the Buffalo Numismatic Association, Inc., its members, the owner and/or the management of the premises in which the bourse is held, the municipality, or other political subdivision in which the premises are located, will furnish or carry any insurance for your protection against any loss or damage of any kind whatsoever. The Buffalo Numismatic Association, Inc., the owners of the premises, the political subdivision in which the premises are located, shall not in any way be responsible for any loss, damage, or injury which may occur to those servants, nor for the loss of any property or material of any kind whatsoever from any cause before, during or after the period covered by the contract, and the undersigned hereby releases the Buffalo Numismatic Association, Inc., its members, the owners and/or other political subdivision in which the premises are located, officers, agents, representatives and servants from and agrees to indemnify the same against any and all loss, claim or expense due to loss, damage or injury.

The applicant hereby agrees to abide by all the rules and regulations of the Buffalo Numismatic Association, Inc., the American Numismatic Association, the premises owners, and/or management. The applicant further agrees to abide by the laws and ordinances of the United States, the State of New York, the municipality and/or other political subdivision having jurisdiction over the premises.

As there is a limit to the number of contracts that can be accepted, priority will be given on a first-come, first-serve basis. Therefore, having read the foregoing provisions, and agreeing with the same, application for bourse space under the conditions specified, is hereby applied for.

All dealers and helpers must be BNA members in good standing.
All bourse participants must be 18 years of age or over and MUST have a N.Y. State Tax Number on file.
Dealers agree to stay to 3:00pm. If not, the contract will be canceled and signee will be charged the regular fee for table rental.
