APPLICATION IS HEREBY MADE FOR BOURSE SPACE FOR THE PERIOD OF THE ABOVE-MENTIONED BOURSES.

Doors open at 8:15 am for dealer set up only. Tables are not transferable and cannot be sublet or shared. Dealers cannot bring additional tables. All containers, inventory cases, totes, etc. must be set up or stored on the dealer's table or directly behind it. Free-standing signage or cases cannot extend beyond 24" above the table's surface. Failure to attend will result in "forfeiture" of said fee. Since the public judges a show's quality by the number of dealers present, contracted dealers must notify The BNA by calling one of the Bourse Contacts five (5) days before the show if they cannot attend. The club has a waiting list of dealers who want to set up. This practice will strengthen the show and help your business, too. Armed guard service will be provided for the bourse area. Armed guard service will be provided in the Dealer parking area from 8:15 am - 9:30 am and again from 3:00 pm - 4:00 pm. The premises must be vacated by 4:00 pm.

Neither the Buffalo Numismatic Association, Inc., its members, the owner and/or the management of the premises in which the bourse is held, the municipality, nor other political subdivision in which the premises are located, will furnish or carry any insurance for your protection against any loss or damage of any kind whatsoever. The Buffalo Numismatic Association, Inc., the owners of the premises, the political subdivision in which the premises are located, shall not in any way be responsible for any loss, damage, or injury which may occur to those servants, nor for the loss of any property or material of any kind whatsoever from any cause before, during or after the period covered by the contract, and the undersigned hereby releases the Buffalo Numismatic Association, Inc., its members, the owners and/or other political subdivision in which the premises are located, officers, agents, representatives and servants from and agrees to indemnify the same against any and all loss, claim or expense due to loss, damage or injury.
